



# **More on our Cover Dog**

Bloodhounds West Southern Chapter member *Landa Coldiron*, along with her search and rescue (SAR) bloodhounds, took her passion for finding lost pets and created *Lost Pet Detection*. Located in Los Angeles County, *Lost Pet Detection* is a rare business that reunites missing pets with their owners using a variety of search methods to successfully track day or night.

In 2007, *Landa* adopted an 8-week-old bloodhound that changed her life forever. From the beginning, "Glory" had off-the-chart drive, dexterity, and physical stamina which stayed with her throughout life. *Landa* recalled that "Glory" was curious, playful, and had strong prey drive. *I always loved her name; it's a strong name and really defined her especially on her searches. She lived up to her name and was full of glory. Her confidence and intelligence levels were high for a bloodhound however, I could never trust her off lead.* 



When asked to recall one of their most notable searches, *Landa* replied, "In February 2013, I received a call from frantic owners whose Pekingese dog, "Goldie," had been lost for nine days in an industrial area of Orange County, CA.

"Goldie" had been taken without permission from the owners by pet sitters to their work place. "Goldie" had managed to slip out of her harness and then vanished. After desperate attempts by the owners to use a megaphone to call "Goldie," scouring the area day and night, and offering a \$1,000 reward, they still had not found their beloved dog. On the tenth day of their search and feeling hopeless that "Goldie" would never be

found, the owners contacted me. I arrived onsite with "Glory" accompanied by my business associate, **Annalisa Berns**, and other search dogs. **Annalisa** has always been instrumental in "Glory's" SAR training and on this particular rainy and gloomy day the three of us were intent on going over and beyond our routine work to reunite "Goldie" with her human family.

**Annalisa** and I worked next to "Glory" who searched her way to a massive outdoor textile manufacturing company. We had to ask permission to get into the area and the textile owner was hesitant at first to let us onto his property. He said there was no dog

and if there had been a dog, one of the many employees would have noticed it. But "Glory" was adamant and determined to go into the area. Permission was reluctantly granted and "Glory" began slowly and meticulously working her way among the factory's rows of material pallets. Suddenly she stuck her head up, sniffed the air and started wagging her tail. We looked under the pallet and that's when we found "Goldie." Annalisa gently coaxed "Goldie" from her hiding spot and we wrapped her in a towel. "Goldie's" owners were notified and she was then rushed to a veterinarian where for two

days she received IV treatments for severe dehydration. Thanks to the successful find by "Glory" and immediate medical care, "Goldie" made a full recovery and is now living happily with her owners in Oregon.

"Glory's" work ethic was extraordinary. She was deployed several hundred times in slightly over a decade. In 2015, "Glory" received the American Humane Hero Dog Award for the Search & Rescue Dog category. The key to "Glory's" success was her incredible drive. Searching for a needle-in-a-haystack is tiring work but "Glory" was dogged-determined and would never give up. She worked long periods of time without losing her focus and she found specific and important clues that human searchers could not find.

However, "Glory's" outstanding successes and accomplishments




extended well beyond her search and rescue missions. She had countless public-relations and television appearances. "Glory" was a delightful and lovable presence and she brought smiles wherever she went. She loved all the attention and lived like a true Rockstar, Landa stated.

**Landa** said when not at work "Glory" enjoyed chewing a pig ear, playing with her bloodhound sisters and kitties, sleeping on her extra-large bed, baying at other dogs walking by when she was in the front yard, and being with my horse.

"'Glory' was a true hero throughout every moment of her short but full life of service to all. Her life was a blessing; her memory a treasure" said Landa.

I hope to see you all soon. Stay safe.



MINUTES FROM LAST BOARD MEETING: Motion by *AI* to accept February 21, 2020 minutes as published in June *Daily Drool*, seconded by *Jenn*. Passed.

REPORT OF THE CORRESPONDING SECRETARY: No activity.

REPORT OF THE TREASURER: **Debbie** presented the attached Treasurer's Report. **Aldo** added that there is \$581.21 in Paypal for various members' dues and a donation to the Banjo Fund. # "Happy National Slobber Appreciation Day" By Marc Bekoff, Ph.D. with Jessica Pierce, Ph.D.

**November 16 is National Slobber Appreciation Day**, a very special day for dogs and some other animals, so let them do what they naturally do with no shame or excuses at all. We're quite serious about this. For the purposes of this brief celebratory essay we're using "slobbering" and "drooling" synonymously.

People often ask why do dogs slobber or drool. It's really something about which everyone who knows dogs has seen and often laughs at, but few truly appreciate or understand. All dogs drool so if you don't like drool it's best not to choose to share your home with a dog. Drool is just a fancy word for saliva, particularly saliva that's no longer in the dog's mouth but is collecting on your pant leg, your cheek, or a wall or floor under the dining room table. A dog's salivary glands are constantly producing and excreting saliva into the mouth. The production of saliva increases when dogs smell or taste something enticing.

Some dogs drool on the run, when they're having a fit and engaged in



zoomies, and they and their dog and human friends often get splattered. Jethro, with whom Marc shared my home for more than 12 years, loved to share his slobber freely and with abandon. His dog friends didn't mind it at all, but some of human friends didn't like it very much.

#### **Drooling is a reflex, not a behavior**

It turns out that drooling is a reflex and not a behavior per se. Dogs can't help it, so it's best not to get mad at your dog for prancing around with drool icicles hanging from their lips or shaking their head and spreading it all over the place. Saliva also is a way for dogs to cool down and excessive salivating can indicate a problem with overheating. And while you can wipe down the dog's face to minimize the mess, there's no way to prevent it — dealing with drool is just part of caring for your pet.

There also are different techniques of slobbering or drooling including what's called "the Double Shoestring," which "takes a bit of practice to master, but some dogs are just gifted with the ability."



#### Drooling is a normal part of being a dog

Dogs drool because they salivate. Drooling is a normal part of being a dog. Like human saliva, dog saliva helps dogs eat and digest so human companions shouldn't get too upset by it. If you really don't mind a little drool but don't like a drool shower, you might avoid certain breeds of dog such as St. Bernards, mastiffs, **bloodhounds**, and Newfoundlands. Dogs of these breeds have loose upper lips, or "flews," and this anatomic abnormality causes them to drool a lot.

When dogs drink, they often drool. This is a nobrainer, but there's more to water and saliva dripping all over the place like icicles than their being uninhibited slobs. There's normal drooling and there's extra drooling, which might start dripping from a dog's jowls when watching their human chow down on food. Saliva production is related to taste and touch sensations in the mouth and on the tongue which activate the part of the brain responsible for these activities.

#### The downside of drooling: Abnormal slobbering needs to be treated

While we often laugh when dogs are drooling like Niagara Falls, it's important to know that excessive drool, or hypersalivation, can be a sign of a serious medical problem, such as periodontal disease, nausea, anxiety, oral or dental disease, or motion sickness. Drooling may also be caused by pain or injury in the mouth that keeps the dog from swallowing.

Are there solutions to drooling? Yes, you carry around a towel or bib to wipe the excess. But there's no reason to do anything drastic like buying your dog "mouth diapers" or having surgery to reshape their lips. Dogs should be free to drool normally. In fact, we can celebrate our dogs' special talents today and all other days.

All in all, drooling is something all dogs do and they can't help it. It's a waste of time to try to stop or to punish your dog for drooling because there isn't any thing they can do about it. It's good to know what a "normal" level of drool is for your own dog. If you see your dog drooling excessively or drool splatter increases in volume, please make an appointment with a veterinarian who can diagnose the situation.



Let's appreciate dogs for who they are and offer an appropriate place for them to slobber when it gets too much for you to handle. It's a win-win for all concerned when we understand just what slobber is and when it can go wrong.



He dropped something and bent down to pick it up. **Ted** was in the middle of an asphalt parking area. No lights were on. He had no cell phone to call me in our room. **Ted** 



couldn't get up. "Mandy" knew what the problem was. She came and stood up against **Ted** (she was on her lead). "Mandy" made herself stiff as a bench. This allowed **Ted** to use her to get up off the ground. "Mandy" knew what **Ted** needed!

Once when our grown daughter, Amy, was visiting us, a tearful subject came up in a conversation at one o'clock in the morning. Amy started bawling. "Mandy" had been sound asleep in her favorite chair and instantly came awake. She went over to Amy (who was standing). "Mandy" stood up on her hind legs and wrapped her front legs around Amy until all was well again.

**Debbie Levy** of Brentwood, CA shared special moments shared with her hounds, "Poppy" and "Hank."





**PITTSBURGH**, **PA** — An Allegheny County Sheriff's Office K-9 is being credited with finding a missing teenager who suffers from serious health conditions.

According to the Sheriff's Office, it all started Thursday afternoon when the teen got into a fight with one of his parents at the family's home in Moon Township. The teen took off and police called in

Sheriff K-9 Deputy Jeff Belback and his K-9 "Ranger," a bloodhound.

Using a pillowcase, the Sheriff's Department says "Ranger" immediately picked up the scent, tracking the teen to Patrick's Pub & Grille in Coraopolis. There, surveillance video showed the teen in the parking lot, then walking away. K-9 "Ranger" picked up the scent again, heading toward a wooded area behind a vacant business on Broadhead Road.



**Deputy Belback** and "Ranger"

searched the area for about an hour and a half before finding the teenager walking out of the woods. He was evaluated by paramedics, and Moon Township police have now taken over the case.

**BETHESDA, MD** – In many ways, "Travis" acts much like an ordinary dog—he plays fetch, runs around with other canines, and enjoys lying in the sun. But the bloodhound also has a job to do: as a trailing dog in the K-9 unit of the Montgomery County Police Department, he follows human scents to help find missing people.

"Travis," who weighs about 100 pounds, is the only bloodhound in the police department's search operations unit, though another hound is set to join him this fall, according to police. There are 21 handlers in the K-9 unit and some work with more than one dog. In addition to "Travis," the unit includes patrol dogs and dogs that are cross-trained for detecting narcotics and explosives.

Police bloodhounds are trained to pick up a scent from personal articles collected from a missing person. Bed linens and clothing are used most often, as well as pieces of gauze containing scents collected from a steering wheel or a vehicle headrest. "We take the dog to the area where the person was last seen, we let the dog walk around and kind of explore for a few minutes, and then we present them with that scent, and then it's off to the races," police *Officer John Greene* says. "They experience smells like we see words."

K-9 unit dogs are also trained from a young age to adjust to various situations they might encounter, such as areas with people, traffic and loud noises. When "Travis" was younger, *Greene* says he would take the dog to places like Home Depot and Great Falls in the C&O Canal National Historical Park so he could get used to the noise made by machines and the crowds he might encounter while trailing a scent.



**Greene** says trailing dogs can help determine the direction a missing person was headed and eliminate areas where searchers think the person may have traveled. "Think of the dog as being our GPS," he says.

In one notable case, "Travis" searched for the father of another county police officer, according to *Greene*. The man, who was in his 70s and had dementia, went missing from a nursing home in Wheaton in 2018. After getting the man's scent from his pillowcase, "Travis" picked up a trail along nearby Bel Pre Road. Patrol officers searching that area found the man, who was uninjured, a mile from the nursing home.

"Travis" is expected to be able to work for another five years or so—most bloodhounds retire by age 9 after showing physical signs of aging that can also cause them to lose interest in the job. When "Travis" isn't searching for missing people, he helps the department connect with county residents. *Greene* says he often takes "Travis" to community outreach events where they demonstrate his skills and children can hug and pet him. "He is a big, lovable dog," *Greene* says. "He is probably one of the friendliest dogs you could imagine.

#### **Ingredients**

- 1 ½ cups rolled oats
- ½ cup shredded cheddar cheese
- 4 strips bacon
- 2 eggs

#### **Directions**

- 1. Preheat oven to 350 degrees Fahrenheit.
- Add oats, cheese, and bacon to the bowl of a food processor and process until ingredients reach a crumb-like consistency.
- Add two eggs to food processor and process until mixture resembles a sticky dough.
- 4. Sprinkle flour or finely ground oats onto a wood cutting board and roll out dough to about ¼-inch thick. Using a cookie cutter, cut out dough into desired shape.
- Transfer dog treats to a parchment-lined baking sheet and cook for 20 minutes.
- Cool treats completely and store in an airtight glass or plastic container.

Marin Humane raised money at its 2019 annual gala, which was held at the shelter for the first time - outside on our field - and guests walked through the shelter to get to the field. It was a good way bring awareness to people of what Marin Humane does and what our facility is like. The event was exceptional. It was a beautiful fall evening with fine food and wine as well as a magnificent auctioneer that helped us raise funds to purchase the much-needed van and incidentals related to the mobile unit. We had never

had a gala like that before!

An independent nonprofit (unaffiliated with The Humane Society of the United States or the ASPCA), *Marin Humane* cares for nearly 8,000 cats, dogs, rabbits and other

animals each year. Director of Development *Joe Lisella* expanded upon the excitement surrounding the new disaster response and adoption vehicle.

What sequence of events lead to the need for the new mobile unit? We have always safely transported animals in more utilitarian vehicles, but having one that could serve many purposes and bring us into the community was our goal with this vehicle.

What are the special features of the mobile unit? We customized the 26-foot vehicle with comfortable capacity for 22 animals to make it readily able to serve many needs in the community. On the passenger side, it features doors that can



roll up and has windows where people can look at animals available for adoption without entering the vehicle. People can also walk through to see additional animals inside. The vehicle has a generator so the animals can remain inside with redundant heat and air conditioning systems that include alarms. There are dedicated areas to finalize an adoption or perform desk duties during a disaster – with a wireless computer network, perform examinations on animals, and a variety of other tasks that our current vehicles are not equipped to do.



How will the unit be used during times of a disaster? One of the biggest challenges during a disaster is having a place to collect, analyze, and respond to the many communications that occur throughout the disaster. This will provide a table space that can be used for these purposes and will also allow us to do cursory field examinations, temporary housing, etc.

How will the unit be utilized for adoptions? Our hope is to bring animals to convenient locations throughout the region to help more adoptable animals find homes. In the past, this would require a considerable amount of effort and depend greatly on weather and other factors. This vehicle is designed for easy loading, display, cleaning, etc. in all weather

conditions so we can spend more time in the community.

Will potential adopters be able to walk through the unit to view shelter animals seeking a forever home? They will, but they are also able to see several of the animals from outside the vehicle when it is parked.

Is the new mobile unit an expansion of your current fleet? It is actually a new type of vehicle for us. Our others are designed for short trips from the field to the shelter while

this one will enable us to set up and function for several hours while keeping the animals as comfortable as possible and transport animals in all weather.

How did you raise funds for the purchase of the mobile unit? The funds were raised as the Fund-a-Need at our 2019 Gala. Over \$200,000 was raised to purchase the vehicle and staff it for the first year.

What types of animals are you able to rescue? Marin Humane is able to rescue all types of animals! We have a broad range of vehicles from livestock trailers to tactical disaster response vehicles – but this is our first one designed specifically for the purposes detailed above.

In Northern California, significant wildfires have occurred and the current drought makes an early start of the fire season likely again this year. How has Marin Humane responded to rescue and care for animals in past wildfire disasters?



Marin Humane has cared for hundreds of pets of those fleeing disasters or whose homes have been destroyed. During the Tubbs Fire of 2017 for example, we transferred all our animals to other shelters so we could make room to house the pets (for free) of those affected by the fires. We also provide disaster care for animals in the affected areas including welfare checks on animals left behind, reuniting lost pets and their families, and helping overwhelmed shelters with their essential operations.

### What new measures are in place to respond to this year's fire season?

In addition to having more staff members highlytrained in disaster response and ready to be deployed if needed, one of the biggest changes in our ability to respond to disasters will be our new multi-use vehicle.

We can use it as a mobile command center, for animal transportation, and for bringing much-needed supplies to hard-hit areas.

What makes "June" and "Scooter" the perfect dogs for the exterior photos on the vehicle? Well, just look at them! "June" and "Scooter's" guardian is a dedicated board member at Marin Humane and made a very generous donation at the Gala to secure their place and support the important work we do. Her efforts and contributions have helped thousands of animals find new homes.









#### Farm Dog Trial (FDC)

**Pat** will be hosting and judging a Farm Dog Trial at her home in Windsor, CA. Sponsored by the Mensona Kennel Club, the trial will be held October 10-11, 2020. Dog and handler only show one at a time keeping social distance. Dogs must test under two judges, three judges will be available. **Pat** says both of her bloodhounds are now AKC Farm Dogs (FDC).



**Pat** will be judging at a Mensona Kennel Club hosted AKC Temperament Test on November 21, 2020 at Flying Cloud Ranch in Petaluma, CA. Temperament is a dog's natural predisposition to react a certain way



to a stimulus. The AKC Temperament Test includes test items in six categories: social, auditory, visual, tactile (touch), proprioceptive (motion), and an unexpected stimulus.

#### **Scent Work Trial**

Pat will also be judging at a Scent Work Trial on November 22, 2020 at Flying Cloud



Ranch in Petaluma, CA. Again, dogs are tested one at a time and masks are to be worn. The sport of Scent Work is based on the work of professional detection dogs (such as drug dogs), employed by humans to detect a wide variety of scents and substances. In AKC Scent Work, dogs search for cotton swabs saturated with the essential oils of birch, anise, clove, and cypress. The cotton swabs are hidden out of sight in a pre-

determined search area, and the dog has to find them.

#### **Bloodhound Story**

## "TRUST YOUR DOG" By Dale Myer

As a former bloodhound handler, I was honored when asked to write a bloodhound story for the newsletter. Soon it hit me that after being a canine runner and then a handler for two decades on the Contra Costa Search and Rescue (SAR) team, this might be a bit of a challenge.

For the folks who don't know me, I joined the San Luis Obispo SAR team in 1975. When I moved to the Bay Area to work, I remained a member and traveled back for major events until I found Contra Costa SAR and went through their membership process in 1980. Back then I was a red-hot man-tracker after years of man-tracking lost people in rural SLO County. We had attended several sessions on man-tracking taught by the US Border Patrol. I soon realized that the majority of Contra Costa searches were urban and my man-tracking skills were 80% useless on pavement.

Next thing I know I'm a "runner" for the team's Bloodhound Squad. A runner watches

out for the dog and handler as the handler is very focused on the dog and less on the surroundings. Our slobbery pals showed me the way past my pavement problem. In 1983 I became the proud owner of "Columbo," a twoyear old male black & tan sniffing machine and relative of "Eli," the late **Mestressat's** first working bloodhound on the team. "Columbo" tasked was with training Bloodhounds instinctively trail humans and the handler must learn to read their dog's body language. I cringe when I hear someone say "they" trained their bloodhound - sure, like I trained my golden retriever to chase tennis balls.

Anyway, just looking back at all the unique events the team encountered as bloodhound handlers, how do I pick one trail to write a story about? We got

called to so many cases that developed into criminal cases that it led me to join the

Sheriff's Reserves and get a longer leash. In other words, if we're chasing a bad guy, guess who's going to get there first?

So here's my bloodhound story. This story is about a routine "missing hiker" in Orinda that "Columbo" (my trainer) and I responded to on March 6, 1984. The report was that *Larry Crow* went for a hike in Orinda. If you drive San Pablo Dam Road north from Highway 24 you pass a sports field prior to the road that takes you up to Tilden Park. There are hiking trails in that area along the creek that feeds San Pablo Dam reservoir. Again, the callout was for a "missing hiker," period. I scented "Columbo" right next to *Mr. Crow's* car. Off we go along the hiking trail with "Columbo" working with purpose. We get to a spot on the trail that meets the creek. "Columbo" walks partially into the creek and sticks his face in the water!

Mind you, this is a dog that runs and hides when it's bath time and he's going to get wet. He's shaking his head side-to-side and it even looks like he's blowing bubbles in the water. I'm thinking this dog has absolutely lost his mind and there were so many people watching and depending on me. Convinced that "Columbo" is off mission, I finally

yank on the leash and tell him "get to work" and "go find!" thinking he's screwing around or taking a drink. Fortunately, I soon noticed from that point on, "Columbo" was no longer working with purpose but seemed to be out for a stroll. I finally had to call it and say I've got nothing since the creek and he's not working a trail anymore. Imagine, try to imagine, my reaction to the news I got several days later that *Larry Crow's* body was found in the creek, bound and weighted down 10-20 feet upstream from where "Columbo" was blowing bubbles. The "missing hiker" becomes a very likely homicide victim. I do not believe the case was ever solved.



It took a while, but I finally come back around to the title of this article, "**Trust Your Dog.**" The evening I got the call of the body recovery, I hand-fed "Columbo," my knowledgeable trainer, a large barbequed Tri-Tip steak while petting his head and trying convey to him how sorry I was and that I was thankful to learn a very important lesson early on....... **Trust Your Dog!** 

**Dale Myer** is a former Contra Costa County Reserve Deputy. He was a member of Contra Costa SAR and a patrol reserve for several decades from 1980 to 2014. He has owned and handled three bloodhounds, all named after famous detectives: (Joe) "**Friday,"** "**Columbo,"** and (Dirty Harry) "**Callahan."**


