


ABC Hall of Fame Working Dog of Merit, MTX TD CGC

Waited a decade for a bloodhound puppy—wanted a dog to trail and also to hopefully “special”. Chose the male I thought had a wonderful head, structure, and movement, smarts, determination, supreme confidence in himself, and also a bit of a mischievous streak—got all that and so much more!

“Steeler” was beyond special—had a harness on and worked before he even got home on day one; won TWO Best in Match ribbons on his three-month birthday; had two mantrailing titles before his first birthday; won two Regional Grand Sweepstakes awards and Best Junior in Futurity; finished his CH with all majors and over

male specials; earned an MTX and Group placements at 16 months; was a Top Ten Bloodhound, a two-time Top Twenty Finalist, and earned a National Specialty AOM. And,

despite requiring spine surgery at age 3, he earned a TD and became an ABC Hall of Fame Working Dog of Merit at age 5 and a CGC at age 7! Go, “Steeler!” He also often participated in Judges’ Education and Meet the Breed events.

ELSE on the planet! Being VERY strong and powerful, and quite headstrong at times, this really came in handy.



He didn’t get lunch at home, but on the road, he was always treated to that meal with plain double cheeseburgers. Like most dogs, he loved cheese, but his favorite human treat was whipped cream from the can.

“Steeler” had a lovely head with a prominent occiput. He had a butterfly-shaped white marking on his chest. He was usually quiet but managed to always get your attention. He enjoyed the ocean and mantrailing through creeks and other bodies of water. As he aged, he continued to work in harness and participate in educational activities. He was a bulldozer




of a dog but was always intuitively on his best behavior when with elderly humans and smaller animals.

“Steeler” left me in August 2020, and he is missed each day.

Hello fellow bloodhound folks.

It's newsletter time again and once again I don't have much to say. That's never stopped me before, of course. Fortunately, shows are happening again. I'll be at Woofstock at the Solano County Fairgrounds in June and hope

to see you there.

Summer is rapidly approaching which means rattlesnakes are out and about. Please keep your pup leashed when you are out hiking. I've even seen them on urban trails. The warming climate is ideal for snakes, not so much for us humans, though. Consider rattlesnake aversion training if you spend much time outdoors.

We also need to be careful about overheating in our hounds. Remember, dogs don't sweat but primarily rely on panting to cool off. Both heat and humidity can increase risk. If you're uncomfortable your dog is likely more so. Be sure to have plenty of water available even on short outings.

I recently attended a course on K9 first aid. Far too many things were covered for me to repeat or even remember but one of the issues brought up is how to carry your dog out if he is injured while hiking. Shortly after taking the course, I assisted a carry-out of an injured dog. Fortunately, a rescue harness was available (this one manufactured by Fido Pro although there are other brands available) which made the job much easier. That dog is now fine. I will be adding a similar harness for my hikes in the future.

Thanks for continuing to support Bloodhounds West through these difficult times. Things will get back to normal eventually.





I'll see you all soon. Hug your hounds and your family and friends!




## ***AKC Meet the Breeds Is Back!***

# ABC Meritorious Service Award


The American Bloodhound Club (ABC) is seeking nominations for their Meritorious Service Award (MSA) to be given to a bloodhound and to a person this year. The award is currently only given in even-numbered years.

Past members of Bloodhounds West who have received this prestigious award include **Myron and Judy Robb** (2001), **Lynne Aquirre** (2002), and **John and Susan Hamil** (2003). Member **Cindi Sims'** bloodhound "Sage" was granted the award in 2010 and **Suzi Paine's** "Thunder" in 2020.

**For the bloodhound**, the ABC states, "Criteria for this award shall be the performance of extraordinary service to the community by a purebred bloodhound. This service must be in the areas of volunteer search and rescue, law enforcement work, therapy work, or any other form of service achievement. Show or performance event records, including ABC mantrailing titles, are not acceptable qualifications for this award. The owner of the bloodhound need not be an ABC member; rather, the dog and owner must have performed exemplary service to the community."

# Bloodhound Stories

## Part 2 of “Waylon,” the Rescue Bloodhound from *West Coast Bloodhound Rescue*

### 2017 – Adoption, Loss, and Fulfillment

Back to the fostering, four weeks passed and “Waylon” was very fond of me. Every



night he would snuggle with me on the couch to watch TV. One night, **Tyler** saw how “Waylon” was attached to me and realized that “Waylon” wasn’t going anywhere. He was officially a part of our pack.

Unfortunately, 2017 was a hard year for us. We lost our basset, “Walter99,” to lymphoma in March and our first bloodhound, “Salvador,” to Hemangiosarcoma in December. We also lost **Tyler’s**

mom and my aunt that was like a mother to me. Having “Waylon” with us was the best thing for us as he kept us happy.

### Waylon’s a Star!

“Waylon” became a hit with his shenanigans. In April 2017, “Waylon” had his first TV gig. He went on the stage for the 2017 Daytime Emmy’s with his two bloodhound brothers and 47 basset hounds from *Daphneyland Basset Rescue* and from the *Basset Hound Club of Southern California*. In



2018, he went on a meet-and-greet with Disney executives for the live action “Lady and the Tramp” movie (they fell in love with him...but this momma wasn’t going to let him go and ruin his special diet, etc.). One

of his biggest star moments was *American Rescue Dog Show* on the Hallmark channel in 2020. He was a contestant in the “Best in Wrinkles” category. His picture (and my

husband's) ended up in the "Readers Digest"! That was a proud moment for *West Coast Bloodhound Rescue*, *Daphneyland Basset Rescue*, his foster moms, and us. It was a true rags-to-riches story ("Waylon" is now rich in toys and in a beautiful home in Ventura with an ocean view).

## Bloat or GDV?

In 2018, we had quite a scare. We were on another filming project with the basset hounds, and "Waylon" was left with a dog sitter. Unknown to the sitter, "Waylon" figured out how to open the screw-on food bin lid and ate approximately ten pounds of dog kibble. When we arrived home, I had a terrible migraine and laid down. **Tyler** said that "Waylon" looked really fat and in jest, I asked if he was bloating. The next thing I know, he is trying to vomit and nothing came up. I immediately went into panic mode and we threw him in the car and drove him to the closest emergency vet. I was so concerned he was going to twist and we were going to lose him. This happened exactly one month after losing "Salvador." We couldn't lose another one in such a short span of time. With luck on our side, there was no twist. It was food bloat. They had to pump his stomach and keep him overnight to make sure he wasn't going to twist. The very next day I took him to his regular vet who performed gastropexy surgery. We are so grateful he survived.



## Family Reunion

In 2019, I was following the Bloodhounds Facebook and noticed a post from a woman in Los Angeles who was celebrating her two nine-year-old bloodhounds' birthdays on May fifth. Waylon's birthday was May fifth as well and he was born in 2010. What are the odds? I pulled out Waylon's surrender form, which had the name of the breeder. I immediately commented on the woman's post and said that my rescued bloodhound was also born on the same day. I asked her where she purchased her hounds and it was the same breeder! "Waylon" has a brother and sister! I was so excited. We kept talking about meeting up but then it was the holidays and then 2020 and you



know how 2020 goes. Unfortunately, his sister “Ruby” passed of cancer rather suddenly. We did meet “Ike,” his brother, in 2021 so there was a bit of a family reunion. “Ike” was very similar to “Waylon” but larger in size (not by weight, he was just a larger hound). It was wonderful as we were able to see puppy pictures and his human mom had pictures of his parents as well. It was nice to know “Waylon’s” history. “Ike” passed in October 2021 of lymphoma. It was bittersweet.

## Present

In July 2021, “Waylon” developed a chronic cough. We were hoping it was temporary; however, we took him the vet to see what was going on. The vet informed us that he has a tumor on one of his lungs near the trachea. Since he is 11 years old, we decided that surgery would have been difficult on him and recovery time would have been slow. We decided we would make him comfortable and happy. We have been using natural therapies to treat his cancer (Vitamin C injections, IP-6, Turkey tail mushrooms, etc.) along with a healthy protein-laden home-cooked diet. The last x-ray showed that the tumor was fading. We know it won’t last but we are hoping that we can celebrate *Cinco de Mayo*, “Waylon’s” 12<sup>th</sup> birthday with him. He loves his chicken tacos so we often celebrate any successes with tacos.

“Waylon” is truly a wonderful, sweet hound. We can take him anywhere and he is bombproof. He finds the good in anyone. He is also a great crooner and sings baritone to the other four hounds in our house. I wish and hope that we can have him for another five years but I know that is impossible.

**2022 marks the 70<sup>th</sup> anniversary of the American Bloodhound Club (ABC).** The Club was founded to oversee the welfare of the Bloodhound breed and to encourage and promote quality in the breeding of pure-bred Bloodhounds to bring their natural qualities to perfection. The ABC endorsed the organization of six regional Bloodhound Clubs in areas where there were sufficient enthusiasts of the breed to meet the requirements of the American Kennel Club (AKC), assisting them in their activities and urging members and breeders to accept the breed standard as approved by the AKC as the only standard of excellence by which Bloodhounds should be judged, and fostering sportsmanlike competition at dog shows and events abiding under the rules of the AKC.


**The ABC is the liaison between the AKC and the six Regional Clubs, including Bloodhounds West, Inc.** The ABC bears the financial and insurance responsibility for all Club activities including regional and national confirmation shows, trailing and agility trials, and performance events which provide attendees the opportunity to see the Bloodhounds perform in whatever area their interest may lie. Without these two vital elements, AKC would not approve organized activities that are such an important part of the Bloodhound world.

For the first time in his miserable life, he decides to do what's right and confess. But how can a guilty man convince lawyers, judges, and politicians that they're about to execute an innocent man? Bloodhounds were involved in the case as shown in this

excerpt from the book:

*“Judge Grale also permitted testimony that had been discredited for many years in many jurisdictions. During the search for Nicole, police used bloodhounds to sniff around for clues. The dogs were given a scent from Nicole’s car and some articles in it, and turned loose. The trails led nowhere, that is, until Donté was arrested. The police then allowed the bloodhounds to sniff through the green Ford van owned by the Drumm family. According to the dogs’ handler, the dogs became excited, agitated, and showed every sign of picking up Nicole’s scent in the van. This unreliable testimony was first played out in a pretrial hearing. Attorneys for Donté were incredulous and demanded to know how they were supposed to cross-examine a bloodhound. Attorney Robbie Flak was so outraged that he called one of the dogs, a bloodhound named Yogi, a “stupid son of a bitch.” Judge Grale held him in contempt and fined him \$100. Remarkably, the dogs’ principal handler was still allowed to testify at trial, and stated to the jury that after thirty years of experience with bloodhounds, he was “absolutely certain” that Yogi had picked up Nicole’s scent in the green van. He was eviscerated on cross-examination by Robbie Flak, who at one point demanded to have the dog brought to the courtroom, sworn in, and put in the witness chair.”*




Bloodhounds...

GLOUCESTER, VA - A K9 bloodhound with the Gloucester County Sheriff's Office helped locate a missing woman Friday night.




According to the sheriff's office, deputies were called to the Founders Mill Subdivision around 5 p.m. for a report of an elderly woman who had been missing for over two hours.





# The Bloodhound's Kitchen



## “No-Bake Peanut Butter Oatmeal Dog Treat”

By *Cynthia Goble*

If you're going to be treating your bloodhounds, you'll want to make sure the treats are good for their health. Some dog treats boast about their excellent organic ingredients, but they can be very expensive. So, why not make your own? These no-bake puppy treats have just five ingredients and are a great summertime treat.

**Servings:** 24 delicious bites

### INGREDIENTS

- $\frac{2}{3}$  cup rolled oats
- $\frac{1}{2}$  cup natural organic peanut butter
- $\frac{1}{4}$  cup wheat bran
- 6 tablespoons unsweetened applesauce
- 2 carrots



### INSTRUCTIONS

1. Combine the rolled oats, peanut butter, wheat bran, and applesauce in a bowl until well mixed.
2. Slice the carrots into twenty-four,  $\frac{1}{2}$ -inch slices.
3. Scoop a heaping tablespoon of the peanut butter mixture into your hand and roll it into a ball. Push a slice of carrot into the middle of the ball and shape the dough into a patty around the carrot. (If you prefer smaller bites for your pup, cut the carrots in half or slice baby-cut carrots and portion a smaller amount of the dough around the carrot.) Repeat with the remaining ingredients. You should be able to make about 24 bites.
4. Store the bites in the refrigerator for up to 2 weeks or keep them in an airtight container in the freezer for a month or two. Feed to your happy hound frozen or at room temperature.


## Bloodhounds in Art




