





"Boots"

Bloodhounds are a sight many have not seen in central California unless visiting a dog show, but as their numbers have declined, so have great representatives of the breed. Fifteen years ago if you had told me I'd have an amazing dog like the one I have today I would have laughed. Bloodhounds were never the breed for me -The slobber, 'houndy' odor and obnoxious behavior were not something I would have ever entertained as owner. Growing up I'd always enjoyed a busy working or sporting breed that has a bit more brain and cooperation with a nice activity level. However, with a few bloodhounds under my belt now I've learned what lovely and intelligent dogs they are and can't see my life without at least one.



My first two boys, Remington and Rüger, were both lovely dogs, but as a younger person I didn't have the training experience I

have now with my current boy, Bootstrap Bill aka "Boots". Briefly, I suffer from seizures as well as a few other disabilities that impact my daily life and as such I utilize a service dog to help mitigate them and alert me to oncoming seizures. (For that reason, I usually have my mom or another person with me at events.) Having a dog to be able to naturally alert and then shape that behavior into a trained task is not an easy feat, but you take what you can get when it comes to the breed since it's a rare ability.



At 8 weeks old I brought "Boots" home and began training by doing small sessions each day and making it all fun. I hoped doing this would shape him into a well-mannered dog, one that could be present but not in the way of people and daily life. He also went to work with me where he listened to all sorts of loud and unexpected sounds on TV and various

video game consoles that constantly playing. This environment created a great atmosphere for safe socialization in an area where he could still learn and begin to understand what would be expected of him as a service dog.


As he matured, we began dabbling in conformation, mainly so that we could safely socialize and work around other dogs with their expected temperament rather than the unknowns of a dog park or pet store. In addition, the shows created a safe haven and fun outlet for us to play and bond as a team while still learning and socializing.

A service dog must have a stable temperament and a bloodhound by nature should be "neither quarrelsome with companions or other dogs." "Boots" fits right into that role.

Fairly early in his life he helped welcome two young human siblings into the world and has been by their sides ever since. When he's not with me he can be found snuggled up with the girls or sleeping by their bed. All of our dogs are monitored with my girls since we want to raise small respectful humans who understand dogs have a time to snuggle and play as well as a time to rest and relax.

When "Boots" isn't actively working he enjoys playing on the beach, romping around with his canine friends and riding rides at Disneyland. He also enjoys "Meet the Breed" and benched shows where he can entertain lots of pets and attention. [To clarify, a service dog is always "on the job" but when not geared up in and in public he can act like a dog.]

After he retires from service work, I believe we will go for our therapy dog title. With his lovely temperament and willingness to please I think he will be an excellent candidate for the therapy dog role.



So, if you see us out and about or at ring side, feel free to come over and say hello. We love being an ambassador for the breed and hope to continue doing so for years to come.

- Report of the Corresponding Secretary none for now per Debbie L.
- Treasurer's Report detailed by Debbie P; current balance without Paypal is \$25,431.51; this includes \$438.93 from last and this years' dues, \$25 to rescue; \$90 from trailing camp fees. Motion to accept the report by Jenn; 2nd by Pam; carried.
- Unfinished Business No new members to discuss.
- New Business
 - Mike McMillan published our Newsletter for years. Can we make him a lifetime member and waive his dues discussed; Lisa recommended that our corresponding secretary send Mike a thank you card. Lisa will also find out how

to name him as an honorary member. Al will reach out to Mike as he didn't renew his membership. We will discuss more next meeting.

- Update our website. Issues are as follows:

- 3. Trailing Trial in Fresno in April. Is anyone entering? Who has questions? How can we help?


- 4. Fresno show in February looks like it will be a big entry, with majors for class animals. We encourage as many entries as possible






Unveils new Annual Appeal Campaign to launch April 1 thru June 3

We received a message on Social Media about two abandoned bloodhound puppies with one having an injury. Someone was taking care of them until we came to help. We were able to pick up Finn first while someone else took care of the injured puppy, Pendleton (aka Penn). We were able to secure him to safety on Friday, February 3rd. Both Finn & Penn were taken to the vet immediately for assessment, immunizations, and treatment.

Fortunately they've come to us at a young age and are now receiving the care and love they deserve and need.

Pendleton's femur break is pretty severe and there is talk about a possible amputation or the use of plates to hold leg together. We have an appointment with a vet surgeon for a consult to determine the best course of action for him. He will require surgery (likely multiple surgeries!).



Brothers, Finn & Penn, did not have a great start in life. Finn came to us, emaciated, blood work on intake stated low protein level, and 6 other things listed in the highs. Add on to that, he had Giardia and his immune system is having issues killing it off. Finn is on the road to full recovery now. With both his protein levels and his blood work finally starting to show normal. However, he's still fighting off the Giardia. We are hoping now his little immune system, with another round of antibiotics, will be able to fight it off. Through all this, Finn is

growing, thriving, and full of play and love!

Fern & Tater came to us via the Riverside County Animal Shelter. They were confiscated along with five other dogs due to neglect. We believe they may be mom and son. They are both very thin and in need of lots of TLC, veterinary care, and basic obedience training. Despite all that they've been through, they're both very sweet and love people and other dogs. They are receiving medical care and lots of love and adjusting well in their foster home.
